PEP Editorial Rules applicable as per PCR-ed3-EN-2015 04 02 or PCR-ed4-EN-2021 09 06

This document describes the editorial requirements to register a PEP certifying the compliance of this document with the PEP ecopassport® program and ISO 14025, namely three components:

- The presence of the "PEP ecopassport®" logo,
- The registration number,
- The check-list box.

A PEP is a corporate document so there are no requirements regarding the style of the document.

The PEP ecopassport ∘ logo:

- Definition according to document PEP- AP0007 in force
- Digital Image available on request from "contact@pep-ecopassport.org"
- Presence on the first page
- Minimum size: defined in PEP-AP0007





The registration number of a PEP ecopassport®:

- The registration number must appear on each page together with the words "PEP ecopassport®"
- All characters are upper case
- Definition: AAAA-bbbbb-Vxx.yy-cc (e.g. ENTR-01962-V01.01-EN)
 - "AAAA": unique code of 4 alpha-numeric characters assigned to the applicant company or its affiliated brand and defined by the company during the first registration
 - o The dashes "-" between the groups of characters form part of the registration number
 - o "bbbbb": unique document number of 5 digits managed by the applicant company
 - o "V" = fixed character relating to the PEP version
 - "xx.yy": identification of the version of the document according to the rules defined in the appendix to this document
 - The application of a modification of a PEP is the responsibility of the company that filed the initial PEP and meets the rules defined in the general instructions of the program in force
 - "xx": "major" version number from 01
 - "yy": "minor" version number from 01
 - The first version of a PEP begins with the number "01.01"
 - o "cc": 2 characters code giving the language of the document according to ISO 639

The check-list box:

- Presence of the following table on the first or last page of the PEP

APPENDIX:

Definitions:

In the event of reissue of a PEP, apply the major / minor categorization described as per the following table and register the PEP according to the general instructions and conditions below:

- Minor modification:

- Submission of the modified document to the PEP ecopassport® program does not require verification by an accredited verifier.
- No change to the end date of validity of the PEP.
- The data are updated online by the company.
- Minor changes are processed in accordance with the rules defined in the version of PCR given on the PEP concerned by the modification. Example: PEP issued according to the PCR "PEP-PCR-ed4-EN-2021 09 06" is the subject of a minor modification during its validity period. This modification will follow the rules of the PCR "PEP-PCR-ed4-FR ...", regardless of the existence of any later version of the PCR.

- Major modification:

- The PEP is considered a new PEP and the conditions for its registration apply.
- The modified PEP is verified by a verifier accredited by the program.
- After checking compliance with the PEP rules in force, the validity period is renewed for the period defined by the general instructions of the program.

The "PEP digital update" tool available via the PEP registration interface can only be used by the PEP registrant in the following situations:

- Where the cases of minor or major changes defined in the procedure are not applicable.
- In the event of agreement or explicit request of the PEP ecopassport® program.
- At the request of the verifier when the data has already been approved and sent to the INIES database and there has been no modification of the PEP pdf file.
- Adding information to the [Name] field of the PEP does not imply a change in the pdf format of the PEP.
- The addition of information in the [Product or brand covered by the text] field of the PEP does not imply any change in the pdf format of the PEP.
